Offseason began yesterday. 214 kids in the program. 99 freshman of the 147 that began with us. We will lose kids. A decision the kids have to make. We treat them as if they are men.

We have 31 seniors out of 127 that came in. To make it in this program to the very end is a big accomplishment. After spring training 195. Could have as many as 340 next year.

To put this in perspective Allen has 223 freshman and they have 26 football coaches.

He wants to treat kids fairly and feels like the school district will put him in a bad position. Puts coach in a bind. Three job offers in 5 years one of them right here. He's turned them all down.

Feedback that he is getting is positive. At the same time we don't want to screws a new high school that is opening up. Stony Point got off to a horrible start our first year.

Talked to the guys at Ridgeview. Give them choice we are okay.

IN regards to funds: asking for \$10000 to offset the cost of redoing fields 3 and 4. Our kids deserve to be on grass fields. \$19800 from elite grass to redo both fields. They would be ready in August of next year. The activity fund will pay for the rest. Quite an undertaking. \$5000 to help offset the cost of the flooring. We have the lockers in the locker room. Purchased twelve more stools. If we can get the flooring done. We are in good shape. We would start doing the fieldst in March. No one can get on them until August. New weight room will be built on the front part of the bond. Goal to have it be independent building. Hopefully a little bit of office space. Scoreboard is coming. It is in production. Lockers look great. It would take a crow bar to break into them. Rings order Thursday. There is a payment plan that can be divided between now and the middle of april. Have to have \$50 Thursday. 4:30 until 6 in this room. Opinons: Tiger pride you will be a man my son (rr leader) Reason we are here is our kids. Hopefully reflect on a great career at Stony Point. Think next year we will be a good football team. Hopefully we will continue to do well. 10-0 JV team. Doesn't necessarily equate into success at the next level. Offensive line was supposed to be bad but we were pretty good. Get the guys we have stronger, bigger, tougher. Scholarships: Some things happening for current guys. Still getting calls. Some guys getting a little bit more interest. January 24<sup>th</sup> is JV banquet. Doors open 6:30. Varsity Feb. 7. Asked to speak at two different clinics. Everything is real positive. Hopefully we continue to get better. As it stands right now every coach is coming back right now. Don't know of anyone who is actively pursuing. Don't anticipate any football coaches leaving. JV more along the lines of 190. a little bit more than last year. Probably 150 Deadline for getting money in Gary's hand for a JV print is 1/16. After the meeting is over can we look at the lockers.
